Overview of experience

I am a Consultant Clinical Neuropsychologist, Clinical Director and NHS Neuropsychology Department Lead with over 20 years' experience working with a range of neurological conditions. I undertook training in Clinical Psychology in Sydney Australia, before relocating to the UK in 2004 where I undertook further specialist training in Clinical Neuropsychology. I have been very fortunate to have been supervised directly by, and published research with pioneers in the field of Neuropsychology, including Professor Barbara Wilson in the UK, and Professors Skye McDonald and Robyn Tate in Australia.

I am registered with the Health Care Professional Council (HCPC) as a Practitioner Psychologist, and the British Psychological Society (BPS) as a Chartered Psychologist. I am on the BPS Specialist Register of Clinical Neuropsychologists (SRCN) and the BPS register of Applied Psychology Practitioner Supervisors (RAPPS).

I have undertaken roles with a high degree of responsibility from very early in my career. My first post qualification role involved both relocation to the UK and clinical leadership of a multidisciplinary team (MDT) providing rehabilitation to people with moderate to severe brain injuries in an inpatient setting for the Brain Injury Rehabilitation Trust (BIRT). At the time, BIRT was at the forefront of research and practice for brain injury rehabilitation which motivated my desire to relocate to the other side of the world.

In the time since I have worked both for private sector organisations and the NHS providing neuropsychological support to people with a range of neurological conditions, both acquired (e.g., traumatic brain injury, stroke, encephalitis) and degenerative (e.g., multiple sclerosis, motor neuron disease, dementia). I have worked both in community and inpatient settings, at different stages of the care pathway. I have also provided support to carers and families. I have expertise in a range of therapies including Cognitive Behavioural Therapy (CBT), Acceptance & Commitment Therapy, Compassion-Focused Therapy, Systemic and Couples interventions, Motivational Interviewing, Narrative Therapy, Cognitive Rehabilitation, Vocational Rehabilitation and Trauma-Focused CBT for Post Traumatic Stress Disorder.

I have been employed at consultant level since 2013, though I also acted in this role due to circumstances in the years leading up to this. In my current role as Lead for the Neuropsychology Department at St Lukes Hospital in Bradford I have responsibility for managing the Community Brain Injury Rehabilitation Team, Epilepsy and Non-Epileptic Seizures (NES) service and referrals for Cognitive Assessment from neurologists. I also provide an expert opinion to the NHS Independent Funding Review (IFR) panel to aid decision-making relating to inpatient rehabilitation for people with neurological conditions. Historically I developed a national Neuropsychology Service for people with Encephalitis and have provided clinical leadership for MDT teams in specialist inpatient rehabilitation settings, and in community settings, often across multiple geographical sites.

For the past 20 years in private practice I have completed work as a treating neuropsychologist, including cognitive assessment, capacity assessment and providing neuropsychological interventions and consultancy. I undertake Part 35 expert neuropsychology assessments for Personal Injury and Medical Negligence claims and expert mental capacity assessments for the Court of Protection. I have completed the Cardiff University Bond Solon Civil Expert Witness Certificate.

Throughout my career, I have worked simultaneously in salaried roles and in private practice. This decision has been motivated by a desire to gain a breadth of experience in understanding and managing both acquired and degenerative neurological conditions, and also expertise in managing the complex interface of neurological conditions and mental health problems including functional presentations. I also have an interest in service development and supporting colleagues to expand their knowledge and skills through supervision and leadership of teams including psychology

departments and multidisciplinary teams. I have retained active involvement in a range of professional activities throughout my career. I currently provide clinical placements for Psychologists in Clinical Training on the Psychology Doctorate at Leeds University. I have been an Honorary Lecturer at Leeds University, and chaired the local British Psychological Society Division of Clinical Psychology. I have published research, a manual for the management of social anxiety in people with brain injury, a book chapter on the role of Narrative Therapy for supporting the spouse following Encephalitis, and I have peer reviewed for the 'Brain Injury' journal. I have supervised a number of Clinical Psychologists to achieve the Qualification in Clinical Neuropsychology conferring entry to the Specialist Register of Clinical Neuropsychologists (SRCN). I have presented at conferences both in the UK and Australia, including at the International Neuropsychology Symposium. I remain committed to Continued Professional Development (CPD).
